Dear Mr. Henricksen: I would like to comment on the fine job that is being done in ASD. This paper is a tremendous aid to any table game enthusiast. The extra fringe players and special teams alone make ASD worth the subscription price. However, I believe ASD is much more. I especially enjoy the comments from other readers. The playing tips carried in previous issues have helped me in managing.

I sincerely hope that critiques of games such as PTG and All-Star Baseball will continue. In the past they have been a complete unbiased analysis which is quite different from the brochures offered by many companies.

With regards to BLM Baseball, I have one observation. Although this game is the best on the market today, it has one error. Force outs at second base can only occur on a hit and run play, consequently there are very few in a normal game. It has been my feeling for a long time that double plays and force outs occur at about the same frequency. Under the present BLM rules double plays take place more often.

Also, in the major leagues the hit and run play usually results with the runner taking second base and the play being made at first.

For example, if the hit and run play is called and the ball is hit to the shortstop, the fielder usually makes the throw to first base. He cannot go to second because the runner usually gets a large jump and would be safe easily. With BLM I suggest that the result boards be changed to include force outs along with double play balls and ground-ball A's.

Also, I have three questions concerning BLM Baseball.

When stealing from third to home the success chances are SBA minus 10. If the defense calls for a no-wind-up pitch, the success chance is SBA minus 25. Should this SBA minus 25 be added to the original SBA minus 10 to form a total reduction of M35?

(Ed.: No—it should be SBA minus 25 only. Note that batter has advantage on no windup, however.)

Also, can the defense call for a no-wind-up pitch with runners on first or second base in order to make stealing more difficult? What reductions should be used if this is the case?

(Ed.: No—the normal pitching no windup is figured in here already.)

If it is possible I would appreciate a reply. I am enclosing a SASE. Today I received the December issue of ASD. I think that the name "All Sports Digest" should remain the same. It is ludicrous to change the name of this great paper.
